

Emergency procedures

In case the UMM system is not available for publishing information, Nord Pool has established routines as stated in this document. Nord Pool Spot recommends that members print out this document in case the web site should become unavailable.

UMM system not working

Members must call the trading desk should they not be able to publish information through the UMM system. The trading desk can be reached at +47 67 10 91 10.

Publishing information through Operational message

- ▶ In case the UMM system is unavailable Nord Pool will publish an Operational message informing members.
- ▶ In such events, Nord Pool can help the member publish information by the use of an Operational message containing the information to be stated in the UMM.
- ▶ The member can fill in the templates in Annex 1 and send them to the trading desk via e-mail to elspot@nordpoolgroup.com. The member MUST call the trading desk to make sure they have received the e-mail and that they will publish the information.
- An Operational message will be published once the UMM system is back in operation. Members must publish information in the UMM system once it is back in operation even if it was published in Operational message.

Operational message not working

- ▶ If the UMM system and Operational messages are not working and the technical problems persist, however, members have to publish information without the assistance of Nord Pool, for example by using their own website.
- Where disclosure is delayed in such circumstance the member will need to consider their compliance with the prohibition of insider trading in article 3 of REMIT and Trading Appendix 11 section 3 of the Market Conduct Rules (MCR) prior to the information actually being disclosed to the market.

Exceptionally delay publication of inside information

- ▶ The member may delay publishing of inside information according to REMIT and the MCR given that the requirements in REMIT article 4.2 and the MCR Appendix 1 section 5.4 (a) are fulfilled.
